### Nomura Global Shariah Strategic Growth Fund - Class B

#### **Fund Commentary and Strategy**

Global stocks dipped in March amidst Trump-driven headlines of renewed tariffs on major US trading partners. However, Europe outperformed as the outcome of the German federal elections led to the prospects of the new government releasing the country's historical 'debt brake', which effectively provides much needed fiscal stimulus to the regional bloc. As such, the Dow Jones Islamic Market ("DJIM") World Index fell by -6.42% and the MSCI All Country World Index ("ACWI") dropped by -4.15% (both in USD terms) for the month. US treasury yields declined sharply over the month while the USD weakened by -0.63% vs. MYR. The Fund's NAV for Class A, recorded -4.56%. Equity investments contributed -4.58% whilst cash, sukuk investments and the currency hedges contributed +0.02%.

#### **Equity Contribution -4.58%**

Increasing rhetoric from the Trump administration on imposing tariffs onto the major trading partners of US dented risk sentiments over the month, leading to global equity markets heading lower. The sell-off was further accentuated by economic data which indicated that consumer sentiments weakened following the uncertainty surrounding tariffs. By sector, communication services and information technology underperformed while energy, materials and consumer staples held up. We reduced equity to 59% from the prior month, and continued to diversify our geographical exposure by switching our holdings away from US to EU and Japan.

Given the increasingly challenging economic environment, we expect the US Federal Reserve to become incrementally dovish as the labour market softens, opening the door to a rate cut sometime in mid-2025. As such, we will cautiously maintain our relatively high equity allocation with the following allocation: (1) defensives such as healthcare (skewed towards medtech) and consumer staples, and (2) pockets of secular growth such as Al and software.

#### Fixed Income & FX hedges Contribution +0.02%

Our sukuk investments via the Collective Investment Scheme ("CIS") namely Dow Jones Global Sukuk ETF contributed +0.02%, as sukuk yields decline, in tandem with lower US Treasury yields on the back of the risk-off environment and weaker macroeconomic data streaming out of the US. Currency-wise, a stronger MYR was a drag on returns.

#### Summary

We have maintained our equities positioning, with a two pronged approach to strike a balance between defensive positioning while still maintaining exposure to sectors that are in secular growth mode. In order to manage the risk associated with the Trump administration, we will diversify into other geographical regions, while remaining faithful to our approach of investing into high quality growth companies. We will continue to maintain sizeable allocation to sukuk investments (via CIS) and Islamic deposits given elevated interest rate levels.


